Business Improvement District (BID) – manage funds & downtown business issues, promotions, marketing, & parking	
Cable TV – advise on Cable TV issues including programming franchising.	
Community Development Authority (CDA) – own & manage senior housing, advise on economic prospects, & provide business loans	
Ethics Board – hear cases involving possible ethics code violations

Parks & Recreation – advise on the operation of city parks, city recreational programs, & forestry matters
